"The Haynesville & Bossier Plays of ETX/NoLa: It's A Thing!

Mr. Clawson has over 40 years of experience in the oil & gas industry, primarily focused in the Ark-La-Tex, Rocky Mountains, and the Upper Texas Gulf Coast regions. He's held various positions in all aspects of geological interpretation, including wellsite work and consulting, petrophysical log analysis, economic analysis of plays and trends, and M&A Analysis. Mr. Clawson was a part of the upper management team within Samson Resources, guiding the horizontal CV Sand Team and Travis Peak Exploitation group, and was also a member of the Haynesville Shale Team. Casey holds a B.S. in Geoscience from Louisiana Tech University in Ruston, LA.



#### 1:30 pm Speaker: Dr. Matt Boyce

"State of Industry"

Matt Boyce PhD earned a B.S. and M.S. from the University of Arkansas in Geology under the guidance of Dr. Walter Manger. He later pursued a PhD at West Virginia University under Dr. Tim Carr. While at Arkansas he was fortunate to be exposed to the discovery of the second major unconventional, the Fayetteville Shale. At WVU Matt worked with Dominion E&P in the initial exploration of the Marcellus.

After his PhD, Matt was hired by ExxonMobil (XOM) as a part of their petrophysics core group. At XOM, Matt worked several plays on the forefront of the global expansion of Unconventionals. He evaluated and operated wells in most of the major

basins in the U.S as well as operating in multiple international plays such as Vaca Muerta, La Luna, Bowland, Dnieper-Donets basin. At XOM Matt also worked a number of conventional plays that included offshore Vietnam, Gulf Of Mexico and Offshore California.

In 2013, Matt moved to SWN where he used his dual skill sets in Petrophysics and Geology. His worked continued on finding new opportunities in the US and co-wrote a new patent (US 3005657A1) that greatly enhanced determining unconventional porosity using core NMR.

In 2018, Matt pursued a new venture that was EPOCH Consulting LLC now named EPOCH Energy Group. He has found success with providing his unique skill sets to clients across industry. He was fortunate enough to be introduced to SIPES by Jeff Allen and had the honor of serving as chairman of the Houston Chapter of SIPES in 2022.
